| <b>1. Inhalation:</b> | No hazard under normal conditions. If necessary move victim to fresh air. If symptoms persist call a physician. Administer CPR if necessary. |

**SECTION 7- SPECIAL PRECAUTIONS AND SPILL/LEAK PROCEDURES****Precautions to be Taken**

**Handling and Storage:** Store in cool ventilated place away from fire hazards, excessive heat, flammable or strong reducing agents. Do not allow product to dry out.

**Other Precautions:** Do not allow product to go below 35 degrees. Apply product in open areas. Keep away from children and pets. Do not contaminate feed, seed or any water sources. Do not eat, drink, smoke or apply cosmetics when using this product.

**Steps to be taken in case of Release or Spill:** Dike area and maximize recovery. Pump into a tank or absorb with diatomaceous earth or sand. Sweep up and place into containers for land application at recommended rates. Prevent entry into sewers or waterways.

**Precautions:** Relatively low toxicity to fish and aquatic organisms. Do not contaminate any waterway, lake stream or estuary by direct application of cleaning of equipment or disposal.
