## CB Mix Liquid Foliar Spray

### PRODUCT INFORMATION

Dyna Gold CB Mix is a liquid foliar formulation of Boron and Calcium designed to give maximum uptake of both of these elements. When used as part of a balanced fertility program, it will correct and prevent calcium and boron deficiencies, especially in rapidly expanding foliage and fruiting structures. It is not designed to correct soil pH or to provide the total Calcium and Boron requirements of the plant. Do not use with foliar fertilizers containing high amounts of polyphosphates.

### DIRECTIONS FOR USE

1. Do not mix with foliar or ground applied liquid fertilizers containing phosphates.
2. A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application.
3. Aerial Application: Use recommended rate in 5 to 10 gallons of water per acre.

### CROP RECOMMENDATIONS

**Vegetables:** Apply 1 to 1½ quarts per acre in enough water to allow for thorough coverage. Two to three applications is recommended for all flowering crops especially tomatoes, peppers, watermelon and squash.

**Row Crops:** Peanuts, use as a supplement to land plaster in 3-4 applications of 1 to 1½ quarts per acre in enough water to allow for thorough coverage.

**Fruit Crops:** Crops requiring additional Boron and Calcium use 3 to 4 quarts per acre in enough water to allow for thorough coverage.
