# Copper

## PRODUCT INFORMATION

Dyna Gold Copper is a liquid foliar formulation designed to correct and prevent copper deficiencies in most crops. If added to the spray tank first it will aid in lowering the water pH. A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant will aid surface coverage which will help leaf absorption.

## CROP RECOMMENDATIONS

**Citrus and Fruit Crops:** Apply 1 to 2 quarts per acre per application in enough water to cover. Repeat applications as needed.

**Vegetables and Row Crops:** Apply 1 to 2 pints per acre per application in enough water to cover. Repeat applications as needed.

**Other Crops Requiring Copper:** Apply lower rates of 1 to 2 pints per acre in adequate water and repeat in two to four applications.

## DIRECTIONS FOR USE

Dyna Gold Copper should be applied at weekly intervals at 1 to 2 pints per application in enough water to cover. Aerial application: 1 to 2 pints per acre in enough water to cover.

## PRECAUTIONS

Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. **KEEP OUT OF REACH OF CHILDREN.** Do not contaminate feed, seed or water supplies. Use of side-shielded safety glasses is recommended.

## FIRST AID

**Skin:** Remove contaminated clothing. Wash with plenty of clean water and soap. Consult a physician.
