PRODUCT INFORMATION

Dyna Gold MZ Citrus Mix is a liquid foliar formulation designed for maximum uptake of zinc and manganese and should correct and prevent deficiencies in most citrus. If added to the spray tank first, it will aid in lowering water pH. The addition of a non-ionic surfactant and/or urea nitrogen will aid in uptake.

CROP RECOMMENDATIONS

Citrus and Fruit Crops: Mature trees: Apply 2-3 quarts per acre in enough water to cover. Repeat applications in summer and fall sprays as needed. Young trees: Apply 2 quarts per 100 gallons of water and wet to thoroughly.

Pecans: Apply 2-3 quarts per acre in enough water to cover.

DIRECTIONS FOR USE

Dyna Gold MZ Citrus Mix should be applied at 2-3 quarts per acre in enough water to cover.

Aerial applications: Apply 1-2 quarts in a minimum of 5 gallons of water per acre.

A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application. The use of side-shielded safety glasses is recommended.

PRECAUTIONS

Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. **KEEP OUT OF REACH OF CHILDREN.** Do not contaminate feed, seed or water supplies.

FIRST AID

Skin: Remove contaminated clothing. Wash with plenty of clean water and soap. Consult a physician.

Eyes: Rinse with clean water for a minimum of 15 minutes. Seek medical attention.
