PRODUCT INFORMATION

Dyna Gold MZF is a liquid foliar formulation designed for maximum uptake of Zinc, Manganese and Iron and should correct and prevent deficiencies in most citrus. If added to the spray tank first, it will aid in lowering water pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and / or urea nitrogen will aid in uptake.

DIRECTIONS FOR USE

Dyna Gold MZF should be applied at 2-4 quarts per acre in enough water to cover. Aerial application: Apply 1-2 quarts per acre in a minimum of 5 gallons of water per acre.

CROP RECOMMENDATIONS

Citrus and Fruit Crops: Mature trees: Apply 2-4 quarts per acre in enough water to cover. Repeat application in summer and fall sprays as needed.

Young trees: Apply 2 quarts per 100 gallons of water and wet thoroughly. Pecans: Apply 2-4 quarts per acre in enough water to cover.
