PRODUCT INFORMATION

Dyna Green #4 is a liquid foliar formulation designed to correct and prevent deficiencies on most tropical fruit and vegetable crops. DynaGreen #4 will aid in lowering water pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant will aid in surface coverage and leaf absorption and is recommended for both ground and aerial application.

CROP RECOMMENDATIONS

For use on vegetables, tropical fruits, turf and ornamentals at rates of 1 to 2 quarts per 100 gallons of water.

DIRECTIONS FOR USE

Foliar Application: Use 1 to 2 quarts per 100 gallons of water. Soil Drench: Use 1 quart per 100 gallons of water. Turf: Use a 1:100 dilution or 4 quarts per 1000 sq. ft. (this would yield per 1000 sq.ft.: 2.45 oz. Fe; 1.89oz. Mn; 1.83 oz. Zn; 1.28 oz. Cu; .11 oz. B; .034 oz. Mo). Aerial Application: Do not exceed 2 quarts in 5 gallons of water. Do not apply by air unless a non-ionic surfactant is used.

PRECAUTIONS

Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. **KEEP OUT OF REACH OF CHILDREN.** Do not contaminate feed, seed or water supplies. The use of side-shielded safety glasses is recommended.

FIRST AID
