

# DYNA GREEN™ COPPER

## Liquid Foliar Element

### PRODUCT INFORMATION

Dyna Green Copper is a liquid foliar formulation designed to correct and prevent copper deficiencies in most crops. If added to the spray tank first it will aid in lowering the water pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and /or urea nitrogen will aid in uptake.

### CROP RECOMMENDATIONS

**Citrus and Fruit Crops:** Use 1 to 2 quarts per acre per application in enough water to cover. Repeat applications as needed.

**Vegetables and Row Crops:** Use 1 to 2 pints per acre per application in enough water to cover. Repeat applications as needed.

**Other Crops Requiring Copper:** Use small rates of 1 to 2 pints per acre in adequate water and repeat in two to four applications.

### DIRECTIONS FOR USE

Dyna Green Copper should be applied at weekly intervals at 1 to 2 pints per application in enough water to cover. Aerial application: Apply 1 to 2 pints per acre in enough water to cover.

### PRECAUTIONS

Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. **KEEP OUT OF REACH OF CHILDREN.** Do not contaminate feed, seed or water supplies.

### FIRST AID
