## PRODUCT INFORMATION

Dyna Green Peanut, Cotton & Soybean Mix is a concentrated formulation for use in both foliar application and fluid fertilizers. Dyna Green Peanut, Cotton, & Soybean Mix should be added to spray tank first and will aid in lowering the water pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant will help leaf absorption.

## CROP RECOMMENDATIONS

Dyna Green Peanut, Cotton & Soybean Mix is recommended to prevent and correct micronutrient deficiencies in the following crops: alfalfa, almonds, avocados, apples, barley, beans, broccoli, cabbage, cauliflower, carrots, celery, citrus, corn, cotton, cucumbers, eggplant, grapes, lettuce, milo, melons, rice, pears, pecans, peppers, potatoes, peanuts, soybeans, strawberries, tomatoes, turf, turnips, watermelons and wheat.

## DIRECTIONS FOR USE

**Foliar Spray:** Dyna Green Peanut, Cotton & Soybean Mix will disperse in water with minimal agitation, and may be applied with most pesticides. Apply 1-3 quarts per acre in enough water to cover through conventional sprayers, and with low volume equipment use 1 quart per acre in at least 5 gallons of water per acre and a non-ionic surfactant such as Active 80.

**Broadcast Ground Application:** Severe Deficiency - 4 quarts per acre; Moderate Deficiency - 2 quarts per acre; Maintenance - 1 quart per acre.

**Row Application:** Use at rates of 2 quarts per acre as a supplement to broadcast application.

## PRECAUTIONS

Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. **KEEP OUT OF REACH OF CHILDREN.** Do not contaminate feed, seed or water supplies. **Caution:** Do not use in a tank mix with high polyphosphate products such as 10-34-0. The use of side-shielded safety glasses is recommended.

## FIRST AID

**Skin:** Remove contaminated clothing. Wash with plenty of clean water and soap. Consult a physician.

**Eyes:** Rinse with clean water for a minimum of 15 minutes. Seek medical attention.

**Internal:** Drink 2 glasses of water. **DO NOT INDUCE VOMITING.** Seek medical attention at once.
