

DYNA GREEN™ VEGETABLE MIX

Liquid Foliar Spray

PRODUCT INFORMATION

Dyna Green Vegetable Mix is a liquid foliar formulation designed to correct and prevent deficiencies in vegetable crops. If added to the spray tank first Dyna Green Vegetable Mix will aid in lowering pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and/or urea nitrogen will aid in uptake.

CROP RECOMMENDATIONS

Vegetable Crops: (Including beans, cabbage, cantaloupe, celery, cucumber, eggplant, endive, lettuce, greens, peas, melons, pepper, potatoes, squash, strawberries, sweet corn and tomatoes) Apply 1 to 2 quarts per acre in weekly applications up to first harvest.

DIRECTIONS FOR USE

Dyna Green Vegetable Mix should be applied at weekly intervals starting with the first spray at 1 to 2 quarts per application in enough water to cover.

Aerial application: 1 quart per acre in 5 to 15 gallons of water.

PRECAUTIONS

Avoid getting in eyes, mucous membranes or on skin. Use with adequate ventilation. Keep container capped when not in use. **KEEP OUT OF REACH OF CHILDREN.** Do not contaminate feed, seed or water supplies. The use of side-shielded safety glasses is recommended.

FIRST AID

Skin: Remove contaminated clothing. Wash with plenty of clean water and soap. Consult a physician.

Eyes: Rinse with clean water for a minimum of 15 minutes. Seek medical attention.

Internal: Drink 2 glasses of water. **DO NOT INDUCE VOMITING.** Seek medical attention at once.

Triple rinse empty containers and offer for recycling or dispose of in accordance with federal, state and local authorities.
