

### **PRODUCT INFORMATION**

**Dyna Gold Cal-N-B** is a liquid foliar formulation of Calcium and Boron. It is designed to give maximum uptake of both of these elements and aid in the prevention and correction of Calcium and Boron deficiency. For best results use **Dyna Gold Cal-N-B** in conjunction with a balanced fertility program. Do not use to correct soil pH or to provide total Calcium and Boron needs. One gallon contains .11 lbs. of elemental Boron and .80 lbs. of elemental Calcium and is equivalent to 1/4 lb. of Solubor and 3 lbs. of calcium chloride. Do not use with foliar fertilizers containing high amounts of phosphates.

## **CROP RECOMMENDATIONS**

*Vegetables:* Apply 1 to 4 quarts per acre in enough water to cover. Two to three applications are recommended for all flowering crops especially tomatoes, peppers, water-melon and squash.

*Row Crops:* Peanuts, should be used as a supplement to land plaster in 3 to 4 applications of 1 to 4 quarts per acre in enough water to cover.

*Fruit Crops:* Crops requiring additional Boron and Calcium use 3 to 4 quarts per acre in enough water to cover.

Do not mix with foliar or ground applied liquid fertilizers containing phosphates. A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application. *Aerial Application:* Use recommended rate in 5 to 10 gallons of water per acre.
