PRODUCT INFORMATION

Dyna Gold Copper is a liquid foliar formulation designed to correct and prevent copper deficiencies in most crops. If added to the spray tank first it will aid in lowering the water pH. Check the compatibilities of untried chemical mixes. The addition of a nonionic surfactant will aid surface coverage which will help leaf absorption.

CROP RECOMMENDATIONS

Citrus and Fruit Crops: Use 1 to 2 quarts per acre per application in enough water to cover. Repeat applications as needed.

Vegetables and Row Crops: Use 1 to 2 pints per acre per application in enough water to cover. Repeat applications as needed.

Other Crops Requiring Copper: Use small rates of 1 to 2 pints per acre in adequate water and repeat in two to four applications.

DIRECTIONS FOR USE

Dyna Gold Copper should be applied at weekly intervals at 1 to 2 pints per application in enough water to cover. Aerial application: 1 to 2 pints per acre in enough water to cover.

A jar test to check the compatibilities of unfamiliar or new combinations should be performed prior to mixing and application.
