PRODUCT INFORMATION

DynaGold Tomato & Pepper Mix is a blend of essential secondary and chelated micronutrients for foliar application designed to correct or prevent deficiencies. These nutrients are specially formulated in the correct ratio for optimum performance, enhanced uptake and assimilation. DynaGold Tomato & Pepper Mix has a low pH and will buffer the water in the spray tank when added first.

DIRECTIONS FOR USE

DynaGold Tomato & Pepper Mix should be applied weekly starting with first spray at 1 to 2 quarts per application and continued throughout harvest in enough water to cover. **Aerial Application:** Use recommended rate in 5 to 10 gallons of water per acre.

CROP RECOMMENDATIONS

Tomatoes & Peppers: Apply 1 to 2 quarts per acre per application in enough water to allow for thorough coverage. Repeat every 7 to 10 days.

Other Vegetables: Apply 1 to 2 quarts per acre. Repeat as needed. **Turf:** Apply 2 to 3 ounces per 1000 sq. ft. and repeat every 2 to 4 weeks. In Florida, application rates should not exceed the recommendations in "BMP's for the Enhancement of Environmental Quality on Florida Golf Courses" found at <http://www.dep.state.fl.us/water/nonpoint/pubs.htm>

Other Crops: Apply 1 to 2 pints per 100 gallons of water. Repeat as needed.

Keep away from children. Do not drink. Do not contaminate feed, seed or water supplies. Do not allow to dry out.

NOTE: Avoid spraying on concrete or painted surfaces as staining may occur. A jar compatibility test should be performed prior to mixing and application of unfamiliar combinations.
