Dyna Green Copper is a liquid foliar formulation designed to correct and prevent copper deficiencies in most crops. If added to the spray tank first it will aid in lowering the water pH. A jar test to check the compatibilities of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and /or urea nitrogen will aid in uptake.

e. DIRECTIONS FOR USE

Dyna Green Copper should be applied at weekly intervals at 1 to 2 pints per application in enough water to cover. **Aerial application**: Apply 1 to 2 pints per acre in enough water to cover.

CROP RECOMMENDATIONS

Citrus and Fruit Crops: Use 1 to 2 quarts per acre per application in enough water to cover. Repeat applications as needed.

Vegetables and Row Crops: Use 1 to 2 pints per acre per application in enough water to cover. Repeat applications as needed.

Other Crops Requiring Copper: Use small rates of 1 to 2 pints per acre in adequate water and repeat in two to four applications.
