## HOMESTEAD MIX LIQUID SPRAY

### PRODUCT INFORMATION

**Dyna Green Homestead Mix** is a liquid foliar formulation designed to correct and prevent deficiencies in vegetable crops. If added to the spray tank first, **Dyna Green Homestead Mix** will aid in lowering the water pH. A jar-test to check the compatibility of new or unfamiliar combinations should be performed prior to mixing and application. The addition of a non-ionic surfactant and/or urea nitrogen will aid in uptake.

### DIRECTIONS FOR USE

**Dyna Green Homestead Mix** should be applied at weekly intervals starting with the first spray at 1 to 2 quarts per application in enough water to cover.  
**Aerial application:** Apply 1 quart per acre in enough water to ensure adequate mixing and coverage.

### CROP RECOMMENDATIONS

**Vegetable Crops:** (Including beans, cabbage, cantaloupe, celery, cucumber, eggplant, endive, lettuce, greens, peas, melons, pepper, potatoes, squash, strawberries, sweet corn and tomatoes) - Apply 1 to 2 quarts per acre in enough water to cover in weekly applications up to first harvest.
