

ZINC 10% Liquid Foliar Spray

PRODUCT INFORMATION

Dyna Green Zinc 10% is a concentrated formulation for both foliar application and use in fluid fertilizers. Caution: Do not use in a tan k mix with high polyphosphate products such as 10-34-0. For foliar application **Dyna Green Zinc 10%** should be added to the spray tan first and will aid in lowering the water pH. Check the compatibilities of untried chemical mixes. The addition of a non-ionic surfactant will help leaf absorption.

DIRECTIONS FOR USE

Dyna Green Zinc 10% will disperse in water with minimal agitation and may be applied with most pesticides. Apply 1-3 quarts per acre in enough water to cover through conventional sprayers. With low-volume equipment use 1 quart per acre in at least 5 gallons of water per acre and anon-ionic surfactant such as Active 80.

Broadcast Ground Application:

Severe Deficiency – 4 quarts per acre; Moderate Deficiency – 2 quarts per acre Maintenance – 1 quart per acre. Row Application: Use at rates of 2 quarts per acre as a supplement to broadcast application.
